**1. Acts against the State chargesheet**

Nature of case: Attempt to Act against the State.

Summary of Charge

Charge: Attempt to Act to against the State. (Given that Mohamed Nasheed, in trips that he made to various islands; having gathered people to various places; in order to overthrow the Government established by Law; with the purpose of creating hatred and enmity among the hearts of the Public towards the Government; having vilified the President of the Republic and the Government, having spoken lies contrary to the truth and having spoken in such ways that create enmity amongst the people towards the Government; given this, when he went to Alif Alif Thoddoo on 30 July 2005, when speaking in various places in the island; given that he said that he would remove Maumoon Abdul Gayoom of Ma. Kinbigasdoshuge from the Rule of Maldives, that in the past some of those who ruled the Maldives had been overthrown from Rule; that in 90 days he would change the present Rule in the Maldives by bringing people from abroad and even by the use of force; given that on the afternoon of 12 August 2005 he led a large number of people to a gathering in front of the Main Centre of the NSS and the Police Headquarters (Republican Square); given that (he) planned to gather more people from G. Dhunfinige' at the Republican Square, given that some people at G. Dhunfinige' cut iron rods intended to be used as weapons of attack; given that many people gathered in areas of Male' and the other atolls and created disturbances that brought damage to the public, law enforcers and government property because of these actions of his; given that he had called on various international parties to impose restrictive measures on the Maldives; under Article 29 of the Penal Code, Mohamed Nasheed is charged with the offense of Attempting to Act Against the State).

Summary of Charge

Charge: Attempt to Act to against the State. (Given that Mohamed Nasheed, in trips that he made to various islands; having gathered people to various places; in order to overthrow the Government established by Law; with the purpose of creating hatred and enmity among the hearts

of the Public towards the Government; having vilified the President of the Republic and the Government, having spoken lies contrary to the truth and having spoken in such ways that create enmity amongst the people towards the Government; given this, when he went to Alif Alif Thoddoo on 30 July 2005, when speaking in various places in the island; given that he said that he would remove Maumoon Abdul Gayoom of Ma.Kinbigasdoshuge from the Rule of Maldives, that in the past some of those who ruled the Maldives had been overthrown from Rule; that in 90 days he would change the present Rule in the Maldives by bringing people from abroad and even by the use of force; Mohamed Nasheed is charged with the offense of Attempting to Act Against the State under article 29 of the Penal Code).
